2024-2026 default rate tariff and regulated rate tariff non-energy compliance filing

Proceeding 29812

Direct Energy Regulated Services

The Alberta Utilities Commission, the independent utilities regulator, will be considering the application for Direct Energy Regulated Services' (DERS) 2024-2026 default rate tariff (DRT) and regulated rate tariff (RRT) non-energy compliance filing to ensure that the delivery of Alberta's utility service takes place in a manner that is fair, responsible and in the public interest. If you feel you may be affected by this application, you can provide input to the AUC to review before it makes its decision.

DERS has filed an application requesting approval for a three-month rate rider for DRT and a six-month rate rider for RRT, to true up its non-energy interim rates for the periods between January 1, 2024, and September 30, 2024, to final 2024 rates approved in Decision 28939-D01-2024.¹ As part of the application, DERS proposed to true up its interim DRT return margin and energy-related charges and energy-related labour costs through Schedule M-1 of the gas cost flow-through rate.

Written submissions are due February 13, 2025.
