2025 non-energy regulated rate tariff application

Proceeding 29821 ENMAX Energy Corporation

The Alberta Utilities Commission, the independent utilities regulator, will be considering the application for ENMAX Energy Corporation's 2025 non-energy regulated rate tariff (RRT) to ensure that the delivery of Alberta's utility service takes place in a manner that is fair, responsible and in the public interest. If you feel you may be affected by this application, you can provide input to the AUC to review before it makes its decision.

ENMAX has filed an application requesting approval of its 2025 non-energy RRT application.

Written submissions are due February 21, 2025.

In an effort to promote efficient processing of this application, the Commission reminds parties to submit the following information as part of their written submissions:

- A full description of the issues and your position on the issues.
- A description of issues that you intend to ask information requests or file evidence on.
- Process steps required and supporting reasons for the requests.
- Whether or not parties and the applicant are amenable to a negotiated settlement process. If parties and the applicant are amenable in pursuing a negotiated settlement agreement, parties should identify details such as the start date and the duration of the proposed negotiations.

The Commission has a statutory mandate to set just and reasonable rates. In this regard, the Commission is the master of its processes and procedures. The Commission employs a proactive approach to managing its procedures and processes in a proceeding to ensure that it discharges its mandate in a fair and regulatory efficient manner. In this context, the Commission will consider all written submissions on process but its determinations are made to ensure the Commission could discharge its mandate in a fair and regulatory efficient manner.
