

# Notice of applications

## Kâpîsimotêt Solar Project

### Neyaskweyahk Group of Companies Inc. has filed applications for a solar power plant, energy storage facility and substation in Ermineskin Cree Nation (Reserve No. 138)

#### Proceeding 29916

#### Applications 29916-A001, 29916-A003 and 29916-A004

The Alberta Utilities Commission (AUC), the independent utilities regulator, will be considering the power plant, energy storage facility and substation development applications in Proceeding 29916. If you feel you may be affected by these applications, you can provide input to the AUC to review before it makes its decision.

#### Written submissions are due June 25, 2025.

Neyaskweyahk Group of Companies Inc. has applied for approval to construct and operate the Kâpîsimotêt Solar Project consisting of a 112-megawatt power plant, a 30.3-megawatt battery energy storage system, and a project substation designated as the Kâpîsimotêt 1058S Substation. The power plant would consist of approximately 222,336 bifacial solar modules.

The facilities would be located on approximately 246.5 hectares of land in the locations described in Table 1, on Ermineskin Cree Nation (Reserve No. 138), near Maskwacis, approximately 9.5 kilometres southwest of Wetaskiwin, Alberta. The applications have been filed under the *Hydro and Electric Energy Act*.

This proceeding does not include the transmission facility and connection of the power plant to the Alberta Interconnected Electric System. The transmission facility work would be applied for in the future as a separate application.
