CI IV Buffalo Plains GP Ltd., CI IV Buffalo Plains LP, CI IV Buffalo Plains HoldCo Ltd. and URICA Energy Real Time Ltd., pursuant to Order 29123-D02-2024, have approval from the Alberta Utilities Commission to share records not available to the public relating to the 494.6-megawatt (MW) Buffalo Plains Wind Farm power plant (asset ID BPW1).

On May 29, 2025, CI IV Buffalo Plains GP Ltd. filed an application with the Commission, pursuant to Section 3(3) of the *Fair, Efficient and Open Competition Regulation* and the provisions of Order 29123-D02-2024, seeking an amendment to the existing order that allows the sharing of non-public records regarding BPW1 between CI IV Buffalo Plains GP Ltd., CI IV Buffalo Plains LP, CI IV Buffalo Plains HoldCo Ltd., URICA Energy Real Time Ltd. and the new asset manager, Peak Wind Canada Ltd.

The Commission approved Application 30072-A001 in Decision 30072-D01-2025.² Pursuant to Section 3 of the *Fair*, *Efficient and Open Competition Regulation*, the Commission orders that:

- (a) Order 29123-D02-2024 is terminated, as of the day of this order.
- (b) CI IV Buffalo Plains GP Ltd., CI IV Buffalo Plains LP, CI IV Buffalo Plains HoldCo Ltd., Peak Wind Canada Ltd. and URICA Energy Real Time Ltd. are permitted to share records for BPW1, as provided by Section 3(1) of the *Fair*, *Efficient and Open Competition Regulation*.
- (c) The term of this order commences on the day of this order, and ends on the earlier of June 1, 2029, or the termination of commercial arrangements between the parties.
- (d) The order applies only to the sharing of information between CI IV Buffalo Plains GP Ltd., CI IV Buffalo Plains LP, CI IV Buffalo Plains HoldCo Ltd., Peak Wind Canada Ltd. and URICA Energy Real Time Ltd. regarding non-public price, quantity and

- availability information pertaining to BPW1, that may relate to BPW1's participation in the Alberta electricity market.
- (e) CI IV Buffalo Plains GP Ltd., CI IV Buffalo Plains LP, CI IV Buffalo Plains HoldCo Ltd., Peak Wind Canada Ltd. and URICA Energy Real Time Ltd. must notify the Commission of the termination of the commercial arrangements between the parties relating to BPW1 within 30 days of the termination of such commercial arrangements.
- (f) CI IV Buffalo Plains GP Ltd., CI IV Buffalo Plains LP, CI IV Buffalo Plains HoldCo Ltd., Peak Wind Canada Ltd. and URICA Energy Real Time Ltd. must notify the Commission of any material changes to the information and continued applicability of any representations contained within applications 29123-A001 and 30072-A001 that may affect the compliance of the parties with the *Fair, Efficient and Open Competition Regulation*, within 30 days of the material changes.
- (g) This order is not transferable.

The Commission may cancel or suspend this order, in whole or in part, or may review this order, in whole or in part, upon its own motion or upon an application by an interested party, in accordance with Section 10 of the *Alberta Utilities Commission Act*.

The Commission may, no later than 60 days from the date of this order and without notice, correct typographical, spelling and calculation errors and other similar types of errors and post the corrected order on its website.
